National Federation and Association (NFA) news

Ireland

The <u>Irish Federation of University Women</u> (IrFUW) marked IFUW Day with a seminar at the Centre for Global Health, Trinity College, Dublin. This took place on Saturday 24 May 2014 and was hosted by Dublin University Women Graduates Association (DUWGA) member Frédérique Vallières. Members of all the Irish associations, and linked members, were in attendance. Frédérique, who is studying for a PhD at the Centre for Global Health, gave an inspiring account of her work to provide secondary school education to Maasai girls in Tanzania. She described the challenge these girls face to avoid early marriage, and told the stories of brave women who had fled their own communities at age 11-12 in order to continue their education. Her colleague Dr Fiona Larkan gave a very well-received presentation on her research with HIV patients undergoing antiretroviral therapy in the Western Cape in South Africa. She included a most interesting and in-depth analysis of patient adherence/compliance, which provided an insight into the challenges these patients face in their daily lives.

Japan

On 30 May 2014, the <u>Japanese Association of University Women</u> (JAUW)) submitted a petition to Japan's Prime Minister and Minister of Foreign Affairs, calling for the immediate release and safe return of over 200 abducted Nigerian girls by Boko Haram. JAUW President Kurumi Nakamura, Vice President Makiko Nawata, and Chairperson of JAUW's International Network Committee, Yaeko Sumi, visited the Gender Mainstreaming Division of Japan's Foreign Policy Bureau and filed petitions in both Japanese and English using IFUW's press release. Spain

The Marbella Branch of the <u>Spanish Federation of University Women</u> (SFUW) celebrated IFUW Day by organising a fundraising lunch of over 60 people which raised enough money for a university scholarship for a girl from Marbella for the 2015-2016 academic year. There was live music and a raffle of valuable objects donated by branch members. For the past two academic years, the Marbella Branch has provided four university scholarships to girls from Marbella. This year (2014-2015) four more girls with excellent academic results and modest family incomes, will also receive scholarships. Sweden

Swedish University Women (KAF) held a seminar at the Nordic Forum on 12-15 June 2014, entitled "Blue stockings, Red stockings - resistance in the Academy during the 20th Century". Over 60 delegates attended the seminar, with every seat occupied! The speakers, Hanna Markusson Winkvist, PhD, Beatrice Christensen Sköld, PhD and Christina Florin, Professor, Gender History, gave insights into the history of KAF and its fight for the rights of women to study at universities and undertake professional work. UN Women Executive Director, Phumzile Mlambo-Ngcuka as well as 90 women's organisations attended this event.

Communications Procedure of the Commission on the Status of Women

Legal victory against child marriage

A new law was passed unanimously by the provincial assembly in Sindh, Pakistan, that prevents anyone under 18 years of age from getting married. The law also punishes those who facilitate, contract or perform such marriages with up to three years in jail and a fine of 45,000 rupees. Read IFUW's policy position on child marriage.
