IFUW participates in Policy Exchange Symposium

On 24 March, IFUW participated in the Public Policy Exchange symposium on "Employment and Social Inclusion in Europe: Ways Forward for the Young Jobless Generation". The one-day event saw several esteemed panellists present on the current status quo of youth unemployment across Europe, as well as various EU, national and private initiatives that are being run to tackle the alarming number of jobless young people across the region. Stefanie Ledermaier from Eurofound - a European Union Agency for the improvement of living and working conditions - opened the seminar by providing some stark realities on the number of young people not in education, employment or Training (NEETs) in the EU. There are currently 14.7 million NEETs under the age of 30 in the EU, amounting to €162 billion in economic loss. Ms Ledermaier went on to explain the recently introduced Youth Guarantee (YG) Programme adopted by the EU, which seeks to tackle youth unemployment. The YG calls on member states to ensure that all young people under 25 receive an offer of a job, apprenticeship, traineeship or continued education within four months of leaving formal education or becoming unemployed. The project is seeing particular traction in countries such as Austria, Finland and Sweden. The critical role of supporting youth entrepreneurship to foster innovation and economic growth was emphasised by Caroline Jenner of Junior Achievement-Young Enterprise (JA-YE) and Andrea Gerosa of ThinkYoung. Both panellists discussed entrepeneurship training specifically focused at young people to raise awareness and develop business-related skills from a young age. Noting a distinct lack of discussion regarding the glaring underrepresentation of women entrepreneurs (less than a third of all entrepreneurs across Europe), and particularly within science, technology, engineering and mathematics (STEM), IFUW asked the panel to consider incorporating a greater focus on including a gender perspective in their work going forward. Both parties responded positively, with Mr Gerosa highlighting a particular course of research that examined the participation of girls and women in STEM, available to view here. Since the conclusion of the event, IFUW has been in contact with certain panellists with a view towards potential collaboration.

Advocacy

Human Rights Council

Friday concluded the 28th regular session of the UN Human Rights Council (HRC), drawing to a close a month of meetings and discussion, where IFUW was represented throughout. A particularly important discussion arose during the adoption of the resolution on the rights of the child, (A/HRC/28/L.28) specifically to promote investment for children across health, education and social protection. The resolution was introduced by the EU and the Latin American and Caribbean Group (GRULAC). Several subsequent states joined the co-sponsorship, with the United States reiterating its commitment to equality in education, especially with regard to gender equality, and expanded upon Obama's new initiative "Let Girls Learn." Other countries – India, Qatar, Russia, and South Africa – agreed to adopt the resolution through consensus, but disassociated themselves with different sections of the resolution, including the national budgeting implications. An especially controversial discussion arose on account of a section of the resolution calling for "access on the basis of equal opportunity and non-discrimination... to include comprehensive evidence-based education on human sexuality..." Certain States purported that this text was "culturally inappropriate," and "one-sided, unbalanced and intrusive in nature." Despite the disassociations, however, the resolution was still adopted unanimously. The entire 28th session of the HRC is available to watch on UN Web TV here.
