#### GWI addresses the 35th session of the United Nations Human Rights Council

On 14 June, Graduate Women International (GWI) addressed the 35<sup>th</sup> session of the Human Rights Council (HRC) with an oral statement delivered by Executive Director, Stacy Dry Lara. In the statement, GWI rebukes corruption on the grounds that corruption impedes States' accountability and gender obligation to education; appeals to States to embrace that educating girls matters and that they recognise that corruption undermines education resources available for women and girls. In the statement, GWI aligned with the Special Rapporteur on the right to education who calls for States to undertake full-scale investigations of fraudulent practices and corruption. GWI also called on States to institute sanctions and establish complaint processes to ensure States' accountability. GWI endorsed the Office of the High Commissioner for Human Rights report on the *Realisation of the Equal Enjoyment of the Right to Education by Every Girl*. The statement is available to view here.

# **GWI summer interns attend United Nations Forum Placing Youth at the Forefront of Humanitarian Action and the 2030 Agenda**

Eighteen percent of world's population is constituted by youth. Persons aged 24 years and younger account for 40% of today's world population making their involvement in humanitarian action and contributors completion of the 2030 agenda crucial. # Graduate Women International - Netherlands (GWI-NL) holds Expert Meeting about female leadership in conflict

Anne Kwakkenbos and Ted Strop-von Meijenfeldt joined GWI-NL's Expert Meeting on 12 May to discuss whether the <u>UN Security Council Resolution 1325</u> works in practice and to consider the issues and implementation of this resolution by the Netherlands. Since the inception of Resolution 1325 in October of 2000, the Netherlands has created three National Action Plans (NAPs) focused on the implementation of Resolution 1325. Adding to the achievements of NAP I and NAP II, the latest NAP, spanning 2016-2019, is a collaboration between government, knowledge institutions and some 60 Dutch civil society organisations and aims to make a significant contribution to women's participation in peace processes and structural change in multiple geographic areas. Specific goals to achieve NAP III were discussed at the Expert Meeting including better protection of women and girls from violence in conflict and post conflict situations; breaking down harmful, underlying gender norms; and ensuring women have equal leverage in conflict prevention and resolution, peacebuilding, relief and recovery at all levels, and ensure that their efforts are acknowledged and supported.

Ted spoke to attendees on the vital role diaspora women play as key figures and role models. Drawing from their multi-cultural knowledge and financial resources, Ted explained that diaspora women make significant contributions to the peace process by exercising influence, due to their roles as intermediaries in both the Netherlands and their countries of origin.

Anje Wiersinga, GWI-NL, called for and encouraged a higher commitment by women in political decision making to be involved in peace talks, the prevention and resolution of conflicts and in the post-conflict situation of reconstruction, and to be attentive listeners to concerned countries. To this end, she is working to organize a side event about the Syrian Peace Talks that will allow face-to-face discussions with parliamentarians to garner support for the implementation of Resolution 1325. GWI thanks and congratulates GWI-NL and their speakers for conducting this important meeting and discussion on women and peacekeeping and how to implement Resolution 1325.

# GWI calls on governments and organisations to protect women and girls per Security Council Resolution 2106

To mark <u>The International Day for the Elimination of Sexual Violence in Conflict</u>, GWI calls on governments and organizations to promote security in areas of conflict to prevent sexual violence, and stop sexual violence as an instrument of war. GWI stresses the importance of recognising that anyone can be a victim of sexual violence, regardless of gender or age. However, girls and women face an increased risk of sexual violence during conflict, as sexual violence towards women is systematically used as a tactic of warfare, torture and terrorism, and women and girls must endure the stigma of being a victim. GWI calls on governments and organizations to protect women and girls per <u>Security Council Resolution 2106</u>, which emphasizes the empowerment of women as a way to reduce women and girls' vulnerability to sexual violence, the protection of women, and the prosecution of perpetrators. GWI also advocates for the de-stigmatization of sexual violence to protect the lives of women and girls who are at risk.

Each Human Rights Council (HRC) in Geneva presents GWI with excellent opportunities to engage with governments and further emphasise our mission. Recently, Canada's Minister for Labour, Patty Hajdu, met with civil society and Permanent Missions in Geneva at the Permanent Mission of Canada. As part of the 35th session of the Council, GWI United Nations representative, Nina Joyce, attended the armchair discussion with Minister Hajdu on "engaging men and boys in eliminating violence against women". Minister Hajdu, previously Minister for the Status of Women, stressed that the present government is fully committed to gender equality and that one way for men in powerful positions to engage is to put their firepower behind women and gender equality. Minister Hajdu comes from civil society and is new to government, having previously run a homeless shelter and conducted advocacy on drug policy. Canada is one of the leading delegations in Geneva on violence against women and traditionally leads the annual resolution of the topic at the United Nations HRC.
