#### **GWI Calls for the Recognition and Protection of Trafficked Women and Girls**

Marking 30 July, World Day against Trafficking in Persons, Graduate Women International (GWI) urges that all people but particularly international, national, state, religious, law enforcement and criminal justice and community leaders to recognize that human trafficking has grown exponentially since the 1990s and we call on them to not stand idly by while this atrocity continues to grow. Human trafficking is the world's fastest growing crime earning, according to the International Labour Organization (ILO), produces profits of \$150 million a year of which commercial sexual exploitation of women, girls, boys and young men earns \$99 billion.

"GWI posits that many of the current policies and programs of globalization have contributed to the acceleration of human trafficking. Globalization has been responsible for unprecedented poverty in many countries and this has facilitated the goals and processes of human trafficking as criminals have lured hapless victims away from their families and communities with the promise of employment. GWI calls on all country governments to ensure the safety of their citizens by providing social safety nets, healthcare, food security and education so that they are not victimized twice – first by country policies and second, by predatory criminals," says GWI President Geeta Desai.

Bina Roy Partners in Development programme funds the Mexican Federation of University Women's oral health project

<u>The Bina Roy Partners in Development Programme</u>, named in memory of GWI's first Asian President, supports locally-developed projects initiated by GWI's National Federations and Associations from developing countries. During the 2017 funding cycle, this programme is funding the Mexican Federation of University Women (FEMU) for their project aiming to improve oral health in low income groups, through talks and presentations delivered to primary schools in Xochimilco, Mexico City.

These groups will be taught preventative measures for oral hygiene, to prevent infections and diseases such as tooth decay which tend to be especially prevalent in areas with high social inequality. The project aims to reduce these diseases in a community of low income families and deliver information on oral hygiene skills, as well as giving the recipients primary dental attention, and allowing for individual question and answers.

GWI congratulates this important project working to improve oral health and improve knowledge of dental hygiene and self-care. This will decrease these issues in this area, something that will undoubtedly have a positive impact on the overall quality of life and health for people living in Xochimilco. GWI thanks and congratulates FEMU and the Projects Committee for arranging and carrying out this event!

#### RAUW now an official member of Pro – Femmes Twese Hamwe

### GWI summarizes Nigeria at the 67th session of CEDAW

On 14 July, GWI summer interns, Selena Cobian and Maria Cipriani, attended the 67<sup>th</sup> session of the Convention on the Elimination of All Forms of Discrimination against Women (CEDAW) held at the Palais de Nations, Geneva. The session examined the matters Nigeria has undertaken in regard to the discrimination of women; paying particular attention to the girls abducted by Boko Haram, gender-based violence, and education. The Nigerian government also elaborated on measures taken towards
