Women Graduates-USA launches guide to action for the Ratification of the United Nations Convention on the Rights of the Child

The Convention on the Rights of the Child (CRC), unanimously adopted by the United Nations General Assembly (UNGA) in 1989, supports children's right to survival, protection, and right to education, as well as other social and cultural rights. Despite having an active role in drafting the convention, the United States is the only UN member not to have ratified the CRC. Women Graduates USA (WG-USA) has taken the lead in passing a resolution asking its members to urge the US Government to ratify this convention by November 20 2015, and has created a website with information about the CRC and letter templates. Interested parties are encouraged to use the available templates to write to President Obama urging him to move forward with the CRC, and commit to this vital legislation.
