#### **GWI Board of Officers meets in Geneva**

The Graduate Women International (GWI) Board of Officers met from 5 to 9 April 2018 at the GWI headquarters in Geneva for their annual face-to-face meeting. On this occasion, Geeta Desai, GWI President, led discussions with the Board and Stacy Dry Lara, GWI Executive Director, to review progress towards implementing the 6-Goal strategic plan as outlined in the Mission and Advocacy and Membership and Communications publications. Final structuring and continued planning for the GWI 33<sup>rd</sup> Triennial and Centenary Celebration, Peace through Education, to be held 25 to 28 July 2019 in Geneva, Switzerland was also a key objective of the meeting. The GWI Board was pleased to host the Swiss Local Arrangement Committee for discussions regarding provisions for several key elements related to the planning of the GWI Centenary Celebration.

### Israel Association of University Women welcomes the President and Secretary General of UWE

The Israel Association of Graduate Women (IAGW) was pleased to host the President of University Women of Europe (UWE), Edith Lammerse, and Roxana Petriusco, UWE Secretary General, on a visit to Israel 12-18 March. In addition to touring historic, archaeological and religious sites in all parts of the country, activities of the Tel Aviv and the Jerusalem chapters were highlighted.

The newly-organized Tel Aviv chapter recently adopted a pilot mentoring project called *Achieving a 'Like'* for Higher Education: Women Seeking Change. Working originally with one boarding school for children in the central city of Netanya, the program has already expanded to 40 students from difficult family backgrounds residing in four boarding schools. The program is designed to raise the girls' self-image, to expose them to a variety of possible careers and to inspire them to further their education. Sessions thus far have focused on opportunities in music and in photography and also in debate and public appearances. Until now 40 volunteers have been recruited to mentor the students one-on-one and also to join in group

activities. The goal is to replicate the project with 400 students and 400 volunteers in the wider central area which includes Tel Aviv. The University of Tel Aviv has been approached to join this initiative by opening university facilities for sponsor meetings between the high school girls and women undergraduate and graduate students or enabling workshops to raise interest in STEM careers.

The Jerusalem chapter invited Ms. Lammerse and Ms. Petriusco to attend an evening of informal presentations by several women who won Israel Association of University Women grants when they were PhD candidates at the Hebrew University in Jerusalem. Prospective new donors were also present at the gathering. The project of grants to women PhD students has been ongoing for over 40 years and includes more than 500 recipients. The unique feature of this project is that there is no age restriction, unlike many other scholarship programs that have a ceiling at 35 years of age. This age limit is particularly restrictive in Israel because so many women start academic studies well into their 20s due to national or military service and/or the pressure of starting families. In the past most of the applicants specialized in the social sciences and humanities and in professions such as social work and teaching. Today about 60% of the applicants study sciences and math, especially biology and chemistry, pharmacology, ecology and environment, and agriculture.

Ms. Lammerse and Ms. Petriusco were also invited to a discussion with police officers in Jaffa about community relations in a mixed neighborhood; a visit to a seminary for priests on the Sea of Galilee; meetings with leaders of several voluntary organizations; and a panel discussion at a meeting in Tel Aviv to recruit new members where the focus was on the role of women in professional fields and the lack of equality. GWI warmly thanks Joan Krauss, IAGW CIR for this comprehensive write up of this very positive exchange between IAGW and UWE, which rightly exemplifies GWI's goal of fostering friendship between graduate women around the world.

#### The University Women's Association Singapore (UWAS) meets with Singapore's first women President

Those present benefitted from the rare chance to forge deeper bonds and explore the

### Dr. Shirley Gillett CSW62 final report

The intense excitement surrounding the 62<sup>nd</sup> session of the Commission on the Status of Women (CSW62) may be over but noteworthy reports are still flowing in from GWI delegates around the worlds. Those reports provide the opportunity to reflect on this very successful session of the CSW. "I have been to several CSW's", said Dr. Shirley Gillett, from Graduate Women New Zealand (GWNZ). "The first one, of course, was a knock out and influential, however, this year's was the best I have experienced from a GWI delegate perspective" she adds. In her final report, Dr. Gillett captures the essence of the CSW unique experience saying, "it is deeply moving to be in an environment with so many women from so many different countries and backgrounds yet with similar desires for a fairer world where women are not only not abused but political powers are exerted for them to be able to develop to their potential. Attending CSW is somewhat overwhelming with so many simultaneous choices and like being in a bubble with a kaleidoscope of impressions and many layers and, whilst exhausting, also energising". Initiated by the German-based NGO WASH United in 2014, this annual awareness day brings together non-profit organisations, government agencies, private sector, the media and individuals from around the world to promote Menstrual Hygiene Management (MHM). GWI is pleased to announce the start of its alliance with Menstrual Hygiene Day (MH Day) in their efforts to catalyse a growing, global movement that recognizes and supports girls' and women's rights and advocate for the integration of MHM into global, national and local policies, programmes and projects. #### **OWSD PhD Fellowships**

The Organization for Women in Science for the Developing World is offering a fellowship to women scientists from Science and Technology Lagging Countries with funds provided by the Swedish International Development Agency. The fellowship aims to contribute to a new generation of emerging women leaders in science and technology and promote effective participation in science and technological developments in their countries. Fellowships are available as two study themes 1) full-time (maximum 4-years) research conducted in another developing country or2) the 'sandwich' theme which allows PhD students to conduct studies in another country while simultaneously completing their degree at home. #### **Nature Research Awards for Inspiring Science and Innovating Science**

Nature Research announced their inaugural Inspiring Science Award and Innovating Science Award, in partnership with The Estée Lauder Companies. The aim of the two new Nature Research Awards is to celebrate and support the achievements of leading women in science and of those who have encouraged

girls and young women to engage with STEM subjects around the world. The Inspiring Science Award welcomes nominations of exceptional scientists who self-identify as female and who are within 10 years of completing their PhD. Nominations from around the globe and from all subject areas are encouraged. **Candidates should be nominated** by laboratory heads, department heads or someone else from their institute. ### — GWI at the United Nations —

#### Intersessional Expert Meeting on the full enjoyment of human rights by all women and girls

On 2 May 2018, GWI participated in the Office of the United Nations High Commissioner for Human Rights (OHCHR) intersessional Expert Meeting at the Palais des Nations in Geneva on the full enjoyment of human rights by all women and girls and the systematic mainstreaming of a gender perspective into the implementation of the 2030 Agenda. At the Expert Meeting, participants discussed gaps, challenges and promising practices in realizing women's rights and mainstreaming a gender perspective in implementing the 2030. The discussions built on already existing assessments and used illustrative examples of areas where the integration of a gender perspective can be strengthened to draw lessons that can guide the operationalization of the 2030 agenda. Key features of the 2030 Agenda are indivisibility and interlinkages of all Sustainable Development Goals, across its social, economic and environmental pillars. The discussion attempted to link a number of SDGs across all pillars through the lenses of women's rights and gender equality. The discussion also highlighted key strategies to enhance synergies across the United Nations (UN) system and other multilateral actors in efforts to support the implementation of the 2030 Agenda in a way that promote women's rights and gender equality. GWI acknowledges the contribution of this Expert Meeting in providing additional guidance on how to integrate a gender perspective in the implementation of the 2030 Agenda and ensure that efforts towards achieving the SDGs promote women's rights and gender equality.

#### UPR30 (NFAs under review: Burkina Faso, Canada, Cameroon, Russia, submitted pre-session reports)

The 30<sup>th</sup> session of the Universal Periodic Review (UPR) Working Group is being held in Geneva from 7 to 18 May 2018. The UPR is a unique mechanism of the Human Rights Council (HRC) aimed at improving the human rights situation on the ground of each of the 193 UN Member States. The UPR assesses the human rights situations of 14 UN Member States each year. With the goal of obtaining targeted recommendations, UPR Info hosts pre-sessions that allow civil society organisations to input their assessments of the reviewing country. Four GWI National Federations and Associations (NFAs) are being reviewed at this session which are Burkina Faso, Canada, Cameroon and the Russian Federation. For each NFA, GWI submitted a pre-session report. Highlights of the recommendations include: Burkina Faso: GWI called on the Burkina Faso government to significantly strengthen, through decisive and measurable political action, its efforts towards the elimination of all forms of violence and discrimination against women and girls that prohibit their achievement of the fundamental right to education; Cameroon: GWI recommended stronger legal and regulatory framework against the pervasive corruption and the rampant impunity seen in the education sector and addressed the urgent need to protect and improve the lives of women and girl refugees, Canada: GWI recommended increasing access to non-traditional education for girls and women through distance such as radio and web-based platforms. GWI remains concerned about the discrimination and violence against indigenous people in Canada and especially indigenous women and girls, and the high suicide rates and calls for the implementation of intensified public awareness programmes in collaboration with CSOs and NGOs on all levels; The Russian Federation: GWI called on the Russia Federation to significantly strengthen, through decisive and measurable political action, its efforts towards the elimination of gender-based violence (GBV) against women and girls that prohibit their achievement of the fundamental right to education.
