Recognition (non-automatic) as a right exercised on a global scale

Right to have the qualifications obtained abroad assessed

Right to transparent, reliable and non-discriminatory procedures, conducted within a reasonable time

Burden of proof based on the accredited authority for the recognition of

Recognition (non-automatic) of qualifications for persons not presenting appropriate documentation (refugees and displaced persons)

Right of Appeal

Internationally consistent recognition processes

Transparency of quality assurance process information for ES

Open mechanisms for obtaining information on higher education institutions and programmes

Establishing a relationship of trust between the various national institutions and the competent authorities responsible for the recognition

More shared understanding of fair and reasonable processes and procedures for recognition
