GWI addresses inequality in trade opportunities for women through its written statement to the 42nd session of the Human Rights Council (HRC42)

On the occasion of the HRC42, GWI is <u>raising awareness</u> through its <u>written statement</u> about the importance of women participating in trade as a means to improve their financial situation. In doing so, GWI voices support of the <u>World Trade Organization Declaration</u> on Gender and Trade on Women's Economic Empowerment, the United Nations Conference on Trade and Development (UNCTAD) <u>Trade and Gender Toolbox</u> and the <u>International Trade Centre (ICT) SheTrades</u> programme. GWI affiliates in 54 countries stand ready to work with these initiatives and organisations to advance the status of women through trade and to demonstrate how women positively complement trade agreements, regionally and internationally.

GWI appreciates the complexity of addressing women's inequality in value chain and trade opportunities yet underscores that trade and gender are two cornerstones for job creation and economic growth. Additionally, the organisation recognises that improving the economic empowerment of women through trade depends on extensive strategic partner networks. To this end, GWI urges Member States and United Nations (UN) agencies to collaborate with international non-government organisations. These organisations offer access to vast globalized networks and local partners who understand regional nuances and who can tailor gender responsive trade partnership strategies from community to community. GWI calls the UN Secretary General to speak about Child Marriage

GWI, along with numerous other concerned <u>Girls Not Brides</u> member organisations, signed a letter calling the UN Secretary General, Antonio Guterres, to urgently address the issue of early and forced marriage around the world. GWI maintains membership in the "Girls Not Brides: Global Partnership to End Child Marriage", a global partnership of more than 1,250 civil society organisations from over 100 countries committed to ending child marriage and enabling girls to fulfil their potential. In this letter, GWI and other signatories are urging Guterres to emphasise during the upcoming Sustainable Development Goals (SDGs)

Summit in New York the need for accelerated action by member states to address child marriage and empower adolescent girls. Each year, 12 million girls are married before the age of 18. Child marriage is a violation of human rights which has far reaching consequences for a girl - and her country. Child marriage puts girls at greater risk of violence and increases her chances of remaining trapped in poverty. It also often results in her being pulled out of school and can leave her with serious health complications or even facing death due to early pregnancy. By not addressing child marriage we risk impeding the development agenda of countries across the world. By signing this letter, GWI calls on governments to take action to accelerate their efforts to end child marriage.

GWI urges Peace through Education on the International Day of Peace (IDP)

IDP, marked annually on 21 September, was established by a unanimous resolution of the UN in 1981. Its mission is to provide a common time period for individuals, organizations and nations to create practical acts of peace on or near a shared date, and to bring together efforts from around the world whose ultimate focus is to promote peace and sustainability. This year, GWI joins the UN in encouraging all nations and people to honour the IDP as a period of non-violence and ceasefire. Accordingly, as an organisation dedicated to peacebuilding through education for 100 years, GWI passed Policy Resolution 2/2019 at its Peace through Education General Assembly and Conference held 25-28 July 2019 in Geneva, Switzerland. Applications are accepted between 15 September and 15 January for the US and Canada programme and the Trinity Washington University programme. GWI UN Representative participates in the UNICEF Executive Board Second Regular Session

Dr. Maureen Byrne, UN Representative, New York recently participated in the UNICEF (United Nations International Emergency Children's Fund) Executive Board Second Regular Session at the UN Headquarters in New-York from 11 to 13 September 2019. Dr. Byrne participates in the Non-Government Organisation (NGO) Committee on UNICEF on behalf of GWI who maintains active membership in the

Committee, based in New York, that comprises approximately 60 organizations that promote children's rights and development globally. In existence for over 50 years, the Committee provides input to the UNICE Executive Board meetings, that are open to Civil Society Organisation representatives. These annual meetings provide an opportunity for further exchange around issues of mutual interest. The statement presented the NGO Committee on UNICEF concerns in three specific areas related to the status of children: downward trends in child well-being, the falling off of children from the 2030 Agenda for Sustainable Development and concerns regarding the fact that NGOs are barred from the special session on children despite the fact that civil society is the biggest shareholder in the implementation of the Convention on the Rights of the Child (CRC). The CRC opens its 82nd session

The CRC opened its 82nd session at the Palais Wilson in Geneva on 9 September 2019. The Committee adopted its agenda and programme of work for the session, during which it will review the reports of Australia, Bosnia and Herzegovina, Mozambique, the Republic of Korea and Portugal under the Convention on the Rights of the Child; the report of Georgia under the Optional Protocol on the sale of children, child prostitution and child pornography; as well as the reports of Georgia and Panama under the Optional Protocol on the involvement of children in armed conflict. The eighty-second session of the Committee will run from 9 to 27 September 2019. All the documents relating to the Committee's work, including reports submitted by States parties, can be found on the session's webpage.
