#### CSW64 format amended in light of current COVID-19 concerns

Following the United Nations (UN) Secretary-General's recommendation to Member States to amend the format of the 64th session of the Commission on the Status of Women (CSW64) in light of the current concerns regarding coronavirus disease (COVID-19), an informal meeting took place in New-York on Monday 2 March 2020. During this meeting, it was decided that CSW64 will convene on 9 March, at 10.00 a.m. (EST), for a procedural meeting. The meeting will include opening statements, followed by the adoption of the draft Political Declaration and action on any other draft resolutions. The session will then suspend until further notification. No general debate will take place and all side events planned by Member States and the UN system, as well as all parallel events planned by Non-Governmental Organisations (NGOs), in conjunction with CSW64, will be cancelled. ### Grand Concert for the Rights of the Child: GWI joins the celebration of an historic convention

On Saturday 29 February 2020, Clémence Mathiaud, GWI Programme Officer represented GWI at the Geneva Grand Concert for the Rights of the Child, celebrating the 30<sup>th</sup> anniversary of the Convention on the Rights of the Child (CRC). Adopted in 1989, the CRC recognised children as their own beings entitled to non-negotiable rights. Nearly all governments - to the exclusion of one - have pledged to respect, protect and promote those rights. This makes the CRC one of the most visionary and universally accepted human rights agreement of all time. Taking place at Victoria Hall, the historic concert hall of the city of Geneva, this concert was attended by local Geneva authorities as well as ambassadors, representatives of international

organisations and NGOs in Geneva. Two of the performers were Juan Jose Pena, a 10-year-old violinist prodigy and already world-famous soloist, as well as a creative and gifted Swiss-based children strings ensemble called The Ministrings. The concert provided an opportunity to raise awareness of the urgent need to step up efforts to make children thrive, and for everyone, at all levels of public and private life, to renew their commitment to protect and promote the human rights of all children.

### Bina Roy Project Highlight - Enhancing Employability Skills for Women's Empowerment in India

The Indian Federation of University Women's Associations (IFUWA)'s Enhancing Employability Skills for the Empowerment of Girls and Young Women project is part of the current 2019-2020 funding cycle of GWI's Bina Roy Partners in Development Programme (BRPID). The project aims to enhance employability skills among girls and young women to achieve economic empowerment. Despite higher enrolments and improved access to education for women it has been observed that young women entering the labour force might often lack employability skills thus hindering their potential for economic empowerment. In order to support the entering of young women and girls into the labour market in India by enhancing their employability skills, IFUWA will provide girls and young women from economically marginalized backgrounds with employability skills training and individual mentoring and support. The project is carried out by IFUWA and their local branch in Delhi, India with the help of local subject experts. The BRPID programme is a grants mechanism of GWI, and its projects are supported by generous donations from impact investors, personal contributions and our own member affiliates around the world. #### International Women's Day 2020: "I am Generation Equality: Realizing Women's Rights"

On 8 March 2020, GWI will join the international community in celebrating International Women's Day, a day for world citizens to shine a spotlight on gender equity issues, how these issues impede global development, and how they can be eliminated. The year 2020 is pivotal for advancing gender equality worldwide, as the global community takes stock of progress made for women's rights since the adoption of the

Beijing Platform for Action, 25 years ago. Several other decisive anniversaries are celebrated this year: the 75<sup>th</sup> anniversary of the UN, the 40<sup>th</sup> anniversary of the Committee for the Elimination of Discrimination Against Women (CEDAW), the 30<sup>th</sup> anniversary of the <u>CRC</u>, the 20<sup>th</sup> anniversary of <u>UN Security Council Resolution 1325</u> and the 10<sup>th</sup> anniversary of UN Women. #### Bulgaria, Pakistan and Zimbabwe under review of 75th CEDAW session

GWI represented its members at the 75<sup>th</sup> CEDAW session, which took place at the UN Office in Geneva, Switzerland, from 10 to 28 February 2020. CEDAW is a committee of 23 experts that ensures and evaluates the implementation of the Convention on the Elimination of All Forms of Discrimination against Women. CEDAW sessions take place three times per year, with each session focusing on reviewing the progress and status of women's rights in a selection of member countries that changes on a rotating basis. The 75th session of CEDAW included the reviews of three GWI NFA countries, Bulgaria, Pakistan and Zimbabwe. Please click on each country name to access their review report. The reviews of these countries emphasis the progress and areas for improvement regarding women's constitutional rights, policies targeting gender violence, representation in government, health, economic empowerment and education. GWI's mission to improve women's education and opportunity to empower women in all aspects of life aligns with the reviews and recommendations from the 75th CEDAW session.

Women's World Summit Foundation (WWSF) 2020 Prize for Women's Creativity in Rural Life

Awarded since 1994 by WWSF - an international, non-profit, humanitarian NGO, serving the implementation of women and children's rights and the UN development agenda - the Prize (\$ 1000 per laureate) honours women and women's groups around the world exhibiting exceptional creativity, courage and commitment for the improvement of the quality of life in rural communities. Nominees should be women and women's groups currently active in rural life whose efforts have not yet been acknowledged by other awards. They may not nominate themselves. Prize laureates are selected by an international Jury composed of WWSF Board of Directors; are announced officially in October and celebrated in their countries on 15 October – International Day of Rural Women. WWSF has a commitment to award annually between five and 10 creative rural women and women's groups around the world. The application deadline is 30 April 2020. #### **European Central Bank Women in Economics Scholarship**

The European Central Bank is one of the newest official institutions of the European Union (EU) with the goal of protecting the value of the euro and keeping prices stable. The Bank's Women in Economic Scholarship offers grants of € 10.000, each, to five female economics students currently enrolled, or about to enrol, in a master's programme in economics at a university or business school in Europe. Successful candidates also have the opportunity to visit the European Central Bank to gain an insight into their cutting-edge research and to learn about the career opportunities they offer. However, applications from a broad range of topics are accepted and do not have to necessarily concern central banking. Applications open in March and close on **30 April 2020**.
