2019 Marjorie Shaw Fellowship winner, Mireille Widmer, presents her work in Nepal - Video In 2019, Mireille Widmer, PhD student from the United Kingdom Institute of Development Studies, was awarded with the Graduate Women International (GWI)/ British Federation of Women Graduates (BFWG) Marjorie Shaw Fellowship for her research project honing down on the governance of security in a secondary city in the Nepali plains, Janakpur. Women and men priorities and approaches differ when it comes to security, and Mireille Widmer's research highlights the benefits of an inclusive participation of women in local governments to address the issues of security in the urban space. Widmer produced an insightful video summary of her ongoing work, accessible HERE. GWI and BFWG are proud to support her critical research into the necessity of equal gender representation in all spheres of government and decision-making. Widmer's research will have far-reaching benefits for both an academic and developmental perspective, as she intends to build on her thesis by broadening this research to further cities. There is much to learn from a comparative study of urban security governance, which unfortunately was not manageable through a single PhD. She is also interested in taking up teaching activities, to pass on some of her experiences and insights to the next generation of development practitioners.



GWI Regional Group, Federation of University Women Africa (FUWA) Meet and Greet



International Literacy Day

The 8 September was designated International Literacy Day (ILD) by the United Nations Educational, Scientific and Cultural Organisation (UNESCO) in 1966 to highlight the importance of literacy for all individuals globally. The recent COVID-19 crisis has affected the access to literacy for the most vulnerable people in the world, especially women and girls, due to school closures. GWI highlights that not only enrolment at school is critical, but also digital and online access to e-learning is mandatory and that literacy allows youth and adults, especially women and girls to fully contribute to the community and acquire critical skills for their future professional and personal life. This year, GWI marks ILD with the release of an infographic with impactful information on literacy which we encourage you to share widely. The infographic can be viewed and downloaded HERE. Child marriage and COVID-19 - Girls Not Brides advocacy toolkit

Girls Not Brides, one of GWI's key advocacy partners, has developed a newsworthy toolkit providing ready-to-use and impactful resources to help continue global advocacy efforts to end child marriage during the covid-19 pandemic. Girls and women, particularly amongst the poorest and social marginalised groups, will be among those most affected by the pandemic. Now is the time to strengthen advocacy efforts to ensure girls and the most vulnerable are at the centre of all government efforts to tackle covid-19 in both the acute and recovery phases of the pandemic. The toolkit includes key messages on prioritising girls during the covid-19 response, tips and tricks for engaging decision-makers and ideas of how to link national advocacy efforts with other global campaigns. GWI Discussion: Commission on the Status of Women (CSW) - Emerging Patterns of Discrimination against Women

In July, GWI opened a very important discussion on the GWI Discussion Network as an opportunity to submit communications to the CSW in order to help identify emerging trends and patterns of injustice and discriminatory practices against women. From this discussion were raised several issues impacting women in different parts of the world. One of the main concerns raised arose from the current pandemic situation, putting women across the world at risk of seeing their fundamental rights being violated. The discussion also led to voice concerns regarding inclusion of women in political negotiations in Afghanistan, over grave violations of human and women's rights threatening women's lives in Spain and the case of Murdered Indigenous Women and Girls in Canada. UN Human Rights Council (HRC) 2020 Elections - NFA Candidates

The <u>HRC</u> is an inter-governmental body within the United Nations system responsible for strengthening the promotion and protection of human rights around the globe and for addressing situations of human rights violations and make recommendations on them. Through Council membership, States commit themselves to 'uphold the highest standards in the promotion and protection of human rights,' and to fully cooperate with the Council and its mechanisms. Every year, GWI issues a statement for each session of the HRC meeting at the UN Office in Geneva. In 2020, among the countries candidate to the October 2020 HRC Elections are several NFA countries: Senegal, Pakistan, Nepal, Russia, Bolivia, Mexico, France and United Kingdom. The International Service for Human Rights (ISHR) has developed a tool to rate the

candidates and provided a list of concrete measures that each candidate should commit to implement as a Council member.
